

## **Master's degree programme in ADMINISTRATION (Faculty of Law and Administration, University of Łódź)**

### **Description:**

This postgraduate Master's degree programme is organized at the University of Lodz by the Faculty of Law and Administration and prepares students for a career in international and internal administration (central or local government, business administration). The programme of the studies includes lectures on international law, legislation of the European Union, Polish domestic law, management and the organization of the civil service.

In the course of the studies participants acquire professional knowledge that enables them to work at the offices of the public administration, as well as, in the institutions of the European Union. The graduates are awarded an M.A. degree in Administration.

### **Candidates profile:**

This programme is predominantly addressed to international students that are interested in studying in Poland – the New Member State of the European Union and the biggest country in Central and Eastern Europe.

### **Duration and fees:**

The programme last 4 semesters (2 academic years)

The payment for these studies amounts to 2500 Euro per academic year plus an additional 200 Euro of registration fee.
